Dear Director Little,

Pursuant to my authority under RSA 21-P:43; RSA 4:45; RSA 4:47; and Executive Order 2020-04, as extended by Executive Orders 2020-05, 2020-08, 2020-09, and 2020-10, I am **amending** my June 8, 2020 authorization, of your written request in attachment, to take the following actions related to CARES Act Coronavirus Relief Funds:

- 1. Transfer \$400,000,000 in Coronavirus Aid, Relief, and Economic Security (CARES) Act funding to the New Hampshire Department of Revenue Administration (DRA) for DRA to distribute the Main Street Relief Funds to recipients, effective through December 30, 2020. (100% Federal Funds)
- 2. Authorize DRA to accept and expend \$400,000,000 from GOFERR to distribute Main Street Relief Funds to recipients. This authorization shall include the authority for DRA to accept, consider, and decide appeals to Main Street Relief Program determinations. Such appeals shall not be subject to RSA 541-A and DRA's determination on such appeals shall be final. The Main Street Relief Fund Program shall not be subject to RSA 21-J:14 whose provisions are waived under this authorization which requires that each applicant's business name, business address, and any grant amount awarded shall be considered public information subject to disclosure to ensure transparency regarding the disbursement of economic relief funds into the economy. Effective through December 30, 3030. (100% Other Funds)
- 3. Authorize GOFERR to enter into agreements with various advertisers, for a total amount not to exceed \$50,000, to advertise the Main Street Relief Fund Program, effective through December 30, 2020. (100% Federal Funds)

The Department of Administrative Services is authorized to take the actions necessary to effectuate this authorization.

EXPLANATION

The Governor has authorized the allocation and expenditure of an initial \$400 million in emergency funding from the CARES Act Coronavirus Relief Fund ("flex funds") to provide emergency financial relief to New Hampshire small for-profit businesses due to the economic disruption caused by COVID-19. In order to be eligible, a business must have its principal place of business in New Hampshire and must have generated less than \$20 million in revenue during the 2019 tax year. In order to provide the most effective relief as quickly as possible, New Hampshire small businesses desiring to obtain relief will first be required to provide information concerning their possible COVID-19-related lost revenues and receipt of Paycheck Protection Program (PPP) loans or any other federal relief. This information will be used to determine appropriate relief criteria based on allowable costs and amounts to meet the needs of eligible small businesses, including whether the initial \$400 million is appropriate or needs to be changed.

The Mandatory Prequalification Period for small for-profit businesses runs May 15, 2020 through May 29, 2020. The announcement of program specifics is scheduled for June 5, 2020 with the Formal Application Period running from June 5, 2020 through June 12, 2020. It is anticipated that the DRA will begin processing relief payments shortly after the filing period closes.
