The Governor's Office for Emergency Relief and Recovery (GOFERR) requests retroactive authority to amend the accept and expend Coronavirus Aid, Relief, and Economic Security (CARES) Act Funding to the New Hampshire Department of Education (DOE) to support the Student Program Enrichment Grant item by extending the end date from December 30, 2020 to March 31, 2021 to support administrative, compliance and monitoring activities, time extension only, no additional funds, effective upon approval by the Governor through March 31, 2021. Originally approved on October 13, 2020, and amended on December 30, 2020, attached. 100% Federal Funds.

EXPLANATION

This amendment is to extend the date by which the already authorized funds to support compliance and monitoring activities by DOE must be used only. While the program funds allocated to the recipients had an end date of December 30, 2020, the Department has the responsibility to perform compliance and monitoring activities, to include reviewing Final Reports submitted by recipients, and providing reports to GOFERR.

The governor has set aside \$1.5 million of CARES Act funding to be available for grants to student programs that provide enrichment opportunities to K-12 students.

Many of these programs, during the period of the pandemic, have had a difficult time connecting with students and connecting students with their programming. This has significantly curtailed the ability of students to participate in important enrichment programming that build important skills.

The Governor's Office for Emergency Relief and Recovery (GOFERR) requests authority to amend the explanation portion of our request to transfer Coronavirus Aid, Relief, and Economic Security (CARES) Act Funding to the New Hampshire Department of Education (NHDOE) to support the Student Program Enrichment Grants by amending the end date for program expenses and loss in revenue, from December 15, 2020 to December 30, 2020, effective through December 30, 2020.
