The Governor's Office for Emergency Relief and Recovery (GOFERR) requests retroactive authority to amend the accept and expend Coronavirus Aid, Relief, and Economic Security (CARES) Act Funding to the New Hampshire Department of Education (DOE) to support the ESL Student Support Fund item by extending the end date from March 31, 2021 to June 30, 2021 to support administrative, compliance and monitoring activities, time extension only no new or additional funds, effective upon approval by the Governor through June 30, 2021. Originally approved on October 14, 2020, amended on November 18, 2020 through the Department of Administrative Services, Bureau of Accounts, and amended January 21, 2021, attached. 100% Federal Funds.
