1. Dear Governor Sununu,

1. The Governor's Office for Emergency Relief and Recovery (GOFERR) requests authority to amend the accept and expend Coronavirus Aid, Relief, and Economic Security (CARES) Act Funding for the Access to Justice Fund - Judicial Council – CASA award, originally approved on July 17, 2020, copy attached. 100% Federal Funds. This amendment will allow the Judicial Council to extend to the grantee the ability to use the remaining balance of the 2020 award for COVID related expenses in 2021, or for services that will assist New Hampshire in responding to the effects of COVID-19 or to recover from the effects of the pandemic by extending the end date for use of the funds from December 30 2020 to December 31, 2021. This authorization is a time extension only, **no additional funds**, effective upon approval by the Governor through December 31, 2021.
2. Subject to approval of the request in paragraph 1 above, authorize the Judicial Council to enter into an amendment to CASA for use of the remaining balances of their 2020 award in 2021, without further approval.

EXPLANATION

In summer of 2020, the Governor authorized an award to CASA, through the Judicial Council, along with a number of other programs to enable charitable entities to continue to provide their important and vital missions during the pandemic or to respond directly to needs created by the pandemic. Consistent with the CARES Act CRF fund provisions, these programs were limited to losses incurred by December 30, 2020 or required that all services or benefits be provided and completed by December 30, 2020.

On December 27, 2020 Section 1001 of Division N of the Consolidated Appropriations Act, 2021, amending the CARES Act CRF provisions by extending the end of the covered period for CRF expenditures from December 30, 2020 to December 31, 2021, was approved by the President.

Following receipt and review of required reporting regarding CASA, it became apparent that they had not been able to fully utilize the amount of their 2020 award for the intended purpose. The COVID-19

pandemic and public health emergency has continued through the present time and is likely to continue to affect New Hampshire through the remainder of 2021. The State should recognize the importance of the charitable missions of CASA to the health and well-being of the citizens of New Hampshire and children in particular and extend to the grantee the ability to use the remaining balance of their award to cover COVID-19 related expenses incurred in 2021 or to continue to respond to and assist New Hampshire to recover from the impacts of COVID-19 in 2021.

Based on the foregoing, GOFERR respectfully requests that the authorization for the Judicial Council program for the CASA award be amended as requested to allow the continued use of the 2020 grants through the end of 2021.

EXPLANATION

The Governor has authorized the emergency allocation and expenditure of \$1,426,960 total to Judicial Council, to cover eligible COVID-19-related expenses incurred from March 1, 2020 to December 30, 2020.

Funds for 1099 Court Appointed Special Advocate (CASA): The Council contracts with CASA of New Hampshire (CASA) to provide guardian ad litem services in child protection cases. CASA's state appropriation represents just a portion of its operating budget. CASA has traditionally received fifty percent of its budget from its state contract and federal grants and the balance from events, private donors and foundations, and other fundraisers. The Council anticipates that due to a decrease in fundraising, CASA's general fund appropriation will be insufficient to meet operating costs through December 31, 2020.

When CASA is unable to accept an appointment in a child protection case, a private guardian ad litem is appointed. The Council also pays for this expenditure. While it is not possible to accurately predict the impact of COVID-19 on the rate of child protection cases, based on information from New Hampshire stakeholders and other sources, an increase in child protection cases should be anticipated. This funding will address CASA's anticipated COVID-19 related revenue shortfalls, and the anticipated caseload increase. In addition to an overall increase in case numbers, the return to traditional classrooms is expected to result in an immediate and significant increase in cases.

Funds for 1092 Guardian Ad Litem: This anticipated child protection caseload increase will also impact the private Guardian ad Litem line. The FY21 appropriation for this budget line is \$150,000. FY20 YTD expenditures were approximately \$345,000. CARES Act funding is only intended to address costs that

were not accounted for in the most recently approved budget. Expenditures would have exceeded the appropriation independent of COVID-19, however, the anticipated timing and influx of cases is a result of COVID-19. An estimated \$200,000 would prepare this budget line for these unanticipated expenditures that will be incurred up to December 30, 2020.

Funds for 1094 New Hampshire Public Defender Program (NHPD): The funds for NHPD are intended to support unanticipated technology upgrades that were necessary to provide constitutionally mandated representation to indigent defendants. Since the pandemic, the New Hampshire Public Defender (NHPD) has had to fundamentally change the way that it provides constitutionally mandated representation to indigent defendants. Court hearings, staff meetings and client visits are now almost all being done remotely. This is expected to continue for the foreseeable future.

Specifically, NHPD upgraded its Microsoft 365 to provide better support for remote workers; it leased Surface Pro 7s to allow for both video conferencing and access to the office's case management system; and it paid to transition to cloud-based storage. The Surface Pro 7s were originally leased, but are now in the process of being purchased.

All unbudgeted expenses due to COVID-19 must be incurred by the recipient before December 30, 2020.
