EXPLANATION

The Governor authorized the allocation and expenditure of \$10,000,000 for Safer Scholars COVID-19 Campus Modification Program to assist private, nonprofit colleges as they modified operations to cover eligible expenses incurred from March 1, 2020 to December 30, 2020. This request amends this allocation from \$10,000,000 to \$8,073,669 lapsing \$1,926,331. It has been determined the allocation has met the needs of the program leaving \$1,926,331 available for re-allocation for emergency relief and recovery efforts.

Further, on June 26, 2020 the Governor also authorized the allocation of \$2,000,000 with \$3,000,000 in a reserve to the New Hampshire Food Bank to increase food purchasing, meal production and provide additional related resources because of COVID-19. On December 16, 2020, the Governor approved allocation of the \$3,000,000 reserve. This request amends that allocation from 5,000,000 to \$3,187,931, lapsing \$1,812,069. It has been determined the allocation has met the needs of the program.

In addition, the Governor authorized the allocation and expenditure of \$116,035,516 for the Healthcare Relief Fund to provide emergency relief to hospitals and other healthcare providers that are serving as an essential component of the State's healthcare system during the COVID-19 pandemic. This request reduces the current allocation from \$116,035,516 to \$113,903,753 lapsing, \$2,131,762. It has been determined the allocation has met the needs of the program leaving \$2,131,762 available for re-allocation for emergency relief and recovery efforts.

At the same time, the Governor authorized the allocation and expenditure of \$1,858,685 for Department of Safety to support the statewide multimedia interoperability system. This request reduces this allocation from \$1,858,685 to \$1,853,685 lapsing \$5,000 and closing the program. It has been determined the

allocation has met the needs of the program leaving \$5,000 available for re-allocation for emergency relief and recovery efforts.

Further, the Governor authorized the allocation and expenditure of \$383,381,438 for Main Street Relief Fund to provide emergency financial relief to New Hampshire small for-profit businesses due to the economic disruption caused by COVID-19. This request reduces this current allocation from \$383,381,438 to \$380,552,227 lapsing \$2,829,211 for re-allocation for emergency relief and recovery efforts.

Moreover, the Governor authorized the allocation and expenditure of \$109,752,326 for Main Street Relief Fund 2.0 to provide additional emergency financial relief to New Hampshire small for-profit businesses due to the economic disruption caused by COVID-19. This request reduces this current allocation from \$109,752,326 to \$109,376,856 lapsing \$375,470 to be available for re-allocation for emergency relief and recovery efforts.

Also, on April 8, 2021, the Governor authorized the lapse request from the original allocation and expenditure of NH Employment Security for the Long Term Care Stipend Program. This request amends the lapse request, reducing the allocation from \$102,000,000 million to \$98,143,200 to \$98,147,700 and reconciling this program by adding \$4,500 to the Long Term Care Stipend Program.

Upon your approval, the GOFERR will work with Department of Administrative Services to return these funds. Returning these unused or excess appropriations to the GOFERR will give the Governor the ability to reallocate \$9,075,343 in available funds to new or existing programs to ensure they are used before December 31, 2021.
